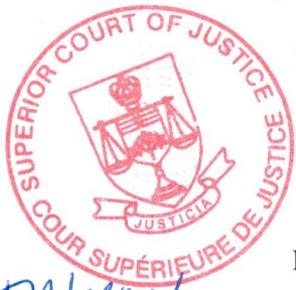

Please Read this Notice Carefully. It May Affect Your Legal Rights.

In October 2021, a lawsuit was commenced on behalf of Instacart “shoppers” who receive orders for groceries and other items through the Instacart app on their smartphone, shop for those orders and deliver the orders to customers. This lawsuit alleged that the defendants misclassified full-service shoppers as independent contractors rather than as employees, thereby improperly withholding the statutory entitlements prescribed under employment standards legislation.

The lawsuit is being discontinued. A discontinuance of the lawsuit means that it is not going forward or being pursued.

Discontinuance of the claims means that any applicable limitation periods in respect of these claims, which may have been suspended, will begin running again, and will ultimately expire (if they have not already done so).
