### 1. KÎKWAY ANIMA MIHCETINÂTOWI SIHKITISAHIKEWIN?

mihcetinâtowin itôtamowin anima misihkeyimowin eta moy mistahi ayisiyiniwak sihkitisahikecik ohci mihcet ayisiyiniwak kâhayâcik peyakwan wiyasiwewin kwecihkeyimowina, pihci ohci peyak ayisiyiniw ka-peyako-sihkitisahiket. mihcetinâtowin itôtamowina kâkîwîcihikiwak ayisiyiniwak ka-kahtinahkik tipahikewin ohci wîsakihtamowina kâ-mâmawi itôtâkawicik, pihtaw ka-peyako sihkitisahikecik kahayiman pihtaw itakihtek, misiwîsakihtamowin, ahpô kotakwa nayihtâwina.

ka-mihceticik ayisiyiniwak itisihkâsiwak “mihcetinâtowin”. kîspin kiteyihîn kiya peyakwan ekota kmihcetinâtowin, semâk kipihtikwahikawin mihcetinâtowin sihkitisahikewin isko kitasiwân “wayawepitisiyan” (itweyimakan e-wayawepitisiyan).

aniki moy kâmihceticik ayisiyiniwak, ekota kâwîtahpisocik mihcetinâtowin wiyasiwewin iteyihtamowina, itisihkâsiwak sihkitisahikewak.

anima Île-à-la-Crosse awâsisak kâ-itisahohcik kiskinwahamâtowikamik (âskaw itisihkâtek Île-à-la-Crosse Mission kiskinwahamâtowikamik, anima Île-à-la-Crosse kitimahtâsowikiskinwahamâtowikamik, ahpô tepiyâhk “Île-à-la-Crosse kiskinwahamâtowikamik”) pimipayihcikâtek ohci 1860 isko 1975-75. eyikwânima mâci nistam kiskinwahamâtowikamik eta iyiniw awâsisak kahitisahohcik kanitawi kiskinwahamâkosicik. Okiskinwahamâkanak aniki mihcet âpihtawikosisânak, mîna iyiniw awâsisak ohci kîwîtinohk Saskatchewan

ôma kâ-kwecihkeyimohk mihcetinâtowin sihkitisahikewin itisihkâtew *Gardiner v The Attorney General of Canada and the Province of Saskatchewan* (Court File Number KBG 936 of 2025). kotak anima kwecihkeyimowin mihcetinâtowin sihkitisahikewin ohci anima Île-à-la-Crosse kiskinwahamâtowikamik (*Aubichon v The Attorney General of Canada and the Province of Saskatchewan*, mâka anihi nîso itôtamowina nîsoscikâtewa ekwa peyak ihtakon sihkitisahikewin e-nîkânohîhk.

sihkitisahikewak ôta sihkitisahikewin aniki nikotwâsik paspewiyiniwak ekwa kâsispohtahowin paspewiyiniwak. kihkâihtamwak okimâwina Canada ekwa Saskatchewan itipahikeyit, kinwâpahcikeyit, pimipayihcikeyit, ekwa nâkateyihthakik anima Île-à-la-Crosse kiskinwahamâtowikamik. kihkâihtamwak Canada ekwa Saskatchewan e-pîkonahkik otôtaskewiniwâwa ka-nâkateyimâcik okiskinwahamâkanak kâhitohtecik anima kiskinwahamâtowikamik, ekwa namôya kanaweyimewak ohci mâyitôtamowina, ekwa okimâwewina kakîtipahamowâcik paspewiyiniwa. Ôhi misihkeyimowina namôya ceskwa tâpwihtamwâ wiyasiwewikamikohk.

nîso Canada ekwa Saskatchewan tâpwihtamwak paspewiyiniwak ohci anima Île-à-la-Crosse kiskinwahamâtowikamik mistahi kwâtakihtâwak.

tahto ayisiyiniw kâkîpimâtisit ikosî pawâhcikinasîs pîsim 9, 2003, ekwa okiskinwahamâkan kâ-nitawi kiskinwahamâsot ekota Île-à-la-Crosse kiskinwahamâtowikamik ikospî mihcetinâtowin kâhispayik, mîna wikamikowâwa, nakatamâkaniwâwa, itôtamakewak, pimipayihcikewak, pîkiskwestamâkewak, ahpô/ekwa tâpwihtamâkewak. mîna kîsikâw okiskinwahamâkanak/kîsikâk kâ-kiskinwahamawihcik.

ôma sihkitisahikewin ohci kîkwaya kâhispayiki ekota, ahpô pihtaw ohci, anima Île-à-la-Crosse okiskinwahamâtowikamik ekwa wîkiwin kâkipahikâtek nânitaw 1975-76. aniki Oblates of Mary Immaculate ekwa Grey Nuns (ohci anima Catholic ayamihewikamik) wîcihihtâsiwak eta e-pimipayihtâcik anima kiskinwahamâtowikamik ekwa wîkiwin.

ôma sihkitisahikewin namôya astew ohci kîkway kâhispayak ekota Rossignol okiskinwahamâtowikamik eta kâ-pimipayihtâcik aniki Île-à-la-Crosse Board. anima Rossignol kiskinwahamâtowikamik mâcipayan nânitaw 1975-76 eta namôya e-wîcihihtâsocik Catholic ayamihâwikamik ekwa namôya wihkâc wîkiwin astew ekota.

### 4. KÎKWAY ASTEW EKOTA KÂ-KWECIHKEYIMOHK TIPAHIKEWIN ASICI CANADA?

---

Canada tâpwihtamwak ka-tipahikecik \$27.335 million ohci “môsihtâwin tipahikewina”, takiskeyihtamihk paspewiyiniwak kahkiyaw e-môsihtâcik wîsakîhtamowin ohci kâhitohtecik anima kiskinwahamâtowin. tahto paspewiyiniw takahtinam môsihtâwin tipahikewin ohci ayitaw:

- isko nânitaw \$10,000 ohci paspewiyiniw kâhitohtet anima kiskinwahamâtowikamik ohci niyânan kiskinwahamâtowin askiya
- isko nânitaw \$15,000 ohci paspewiyiniw kâhitohtet anima kiskinwahamâtowikamik ohci niyânan kiskinwahamâtowin askiya ayiwâk.

mîna ôma apisîs kiskinwahamâtowina askiya, kiyâm âta ekahikohk e-cimâsik eyako anima.

ohci paspewiyiniwak kâ-pimâtisicik ikospî pawâhcikinasîs pîsim 9, 2003, mâka nipiwak aspin ikospî, anima tipahikewin kahitohtemakanew isi wikamikowâwa (tamâmîkiyit owikamikiwâwa itôtamâkewâw(a), pimipayihcikew(s), ayiwak.) kîspin paspewiyiniw nipi makîkway nakatamâkewin masinahikan, ekwa namôya awiyak wikamik pimipayihcikew e-ahiht, anima tipahikewin kahispayan isi paspewiyiniw kâ-pimâtisiyit wahkômâkaniwâwa, tâpiskoc wîkimâkana,

otawâsimisiwâwa kîspin namôya wîkimewak awiya ikospî kâ-nipicik, kîspin onakatamâkaniwâwa kaskihtâwak ka-tâpwihtamihk anima kwecihkeyimowin.

kîspin \$27.335 million namôya ikahikohk tatipahikehk kahkiyaw ekota môsihtâwin tipahikewina, tahto Experience Payment kanîkipicikâteu, itweyimana kahkiyaw tipahamâtowin ka-nîpicikâteu peyakwan itahkihtek. Peyak mistahi e-kiskeyihtahk iteyihtam nânitaw 2,060 paspewiyiniwak e-pimâtisicik pawahcikinasi pîsim 9, 2003, namôya mâskots ka-nîkipicikâteu ekota wâpahtamowin môsihtâwin tipahikewina.

kîspin îskopayiw sôniyaw ohci kahkiyaw ekota môsihtâwin tipahikewina kîsitipahikewin, kahkiyaw ekwa ana \$27.335 million kahispayiw ekota anima nakatamowin tipahikan.

anima nakatamowin tipahikan eta sôniyâw e-âstapit eta kahâpacihiht ka-tipahamihk “nakatamowin atoskâcikana” ohci ka-wîcihikocik paspewiyiniwak, owahkômâkaniwâwa ekwa mâmawinitowina. nakatamowin atoskâcikana anihi atoskâcikana ka-wîcihihtâsiwimakahki nâtauihowin, miyomahcihowin, kwaskascikewin, kiskinwahamâsowin, kiskisiwin, ekwa/ahpô iyiniw pîkiskwewina (Michif, mîna neh yawewin ekwa cîpwiyanemowin) kanaweyihcikewin.

Canada ka-tipahikewak \$10 million isi ekota nakatamowin tipahikan, mîna sôniyâw kâ-iskoniht ohci anima môsihtâwin tipahikewina tipahikan. anima nakatamowin tipahikan ka-pimipayihâtawak paspewiyiniwak, isi not-for-profit atoskewin, eta e-miywâsik, sâpowâpahtamihk itôtamowin ka-tipahamihk Legacy atoskâcikana.

anima tipahikewin asici Canada astewa ôhi kîkwaya:

- isko \$5 million kâhitakihteki tipahikewin pimipayihcikewin (mîna kîkwaya tâpiskoc kinwâpahtamihk kwecihkeyimowin masinahikana, wihtamihk ayisiyiniwak kwecihkeyimowiniwâwa, akihtamihk tipahikewina, ekwa kâ-sipwetisoht sôniyâw)
- ekwa \$5 million osici ka-tipahamihk ahkami wiyasiwewin atoskewin isi Saskatchewan (kîspin tâpwihtamowin anima tipahikewin asici Saskatchewan ohci owiyasiwew ekwa anima sihkitisahikewin pônipayan).

## 5. KÎKWAY ASTEW EKOTA KÂ-KWECIHKEYIMOHK TIPAHIKEWIN ASICI SASKATCHEWAN

---

Saskatchewan tâpwihtamwak tatipahikecik \$40.2 million ta-mînostâcik anima sihkitisahikewin kâ-masinahohcik. anima tipahikewin sôniyâw ohci Saskatchewan kahâpacihiht ka-mînopitamihk anihi “newo cimatakana” ohci mihcetinâtowin kâ-wîtahpisocik kwecihkeyimowina: kahkiyaw môsihtâwin; peyako kitimahtâsiwin; kiskisiwin nâtauihowin; miyomahcihowin; kiskinwahamâsowin; pîkiskwewin; sihkikewin ekwa kiskisiwin; ekwa wiyasiwewin itakihtewina ekwa tipahikewin pimipayihcikewin itakihtewina. Sihkitisahikewak wihtamwak ana \$40.2 million ka-nîswayakipitaw omisi esi:

- nîkân, ka-tipahamowihcik okiskinwahamâkanak kâ-môsihtâcik misikwâtakihtâwin ahpô kâhotihtinecik kitimahtâsiwin ekota Île-â-la-Crosse;
- nîso, ayiwâk sôniyâw katakwahiht ohci môsihtâwin tipahikewina osci kitimahtâsowikamikwa okiskinwahamâkanak/paspewiyiniwak kahayâcik kapîtipisk ekotawihk wikamikwa; ekwa
- ka-tipahamihk wiyasiwewin itakihtewina ekwa tipahikewin pimipayihcikewina itakihtewina.

anima tipahikewin ohci misi-wîsakihtamowin ahpô kâ-otihtinikawihk ka-tipahikâteu newo ayâwinihk, tâmayikohk ohci \$50,000 isko \$235,000, tâmiyikohk kitimahtâsowin itôtamihk, ekwa tâmayikohk esi mayipicikewimakahki ikospî ohci. tâpiskoc anima tipahikewin asici Canada,

tipahikewina ohci paspewiyiniwak kâ-nakataskecik itâp pawahcikinasîs pîsim 9, 2003, kahitohteyimakan isi paspewiyiniwak wikamikwa ahpô onakatamâkaniwâwa, kîspin kaskihtâwahk tâpwe wiyâwâw anima kwecihkeyimowin.

tâmayikohk anima môsihtâwin tipahikewin ka-takwahiht sôniyâw ka-mamisîtocikâtew tâmayikohk e-tipahikehk ohci misi-wîsakihtamowin ahpô otihtinikawihk kitimahtâsowina kwecihkeyimowina. ka-takwastâhk tipahikewin tepiyâhk ohci kitimahtâsowin okiskinwahamâkanak (ahpô owikamikowâwa ahpô nakatamâkaniwâwa) ka-mâmitoneyihtahkik anihi ayiwâk kitimahtâsowina kâ-môsihtâcik ekota Île-à-la-Crosse kiskinwahamâtowikamik, ekwa ka-tipahikehk tâmayikohk askiya tahto okiskinwahamâkan kâhitohtet anima kiskinwahamâtowikamik.

nânitaw \$1 million ohci anima tipahikewin tipahikan ka-nitaweyihcikâsow ohci itakihtewina ka-pimipayihtâhk ôma tipahikewin, mîna ayiwâk ka-pimipayihtâhk tipahikewin asici Canada. kîspin anima tipahikewin asici Saskatchewan tâpwihtâtew mâka anima tipahikewin asici Canada moy tâpwihtâtew, anihi pimipayihcikewina ayiwâk kahispayinwa.

misteyihtâkwan takiskisihk anihi tipahikewina e-pihtostâhk ekwa moy peyakwan itasteki. owiyasiwew kâkîtâpwihtam makîkway, peyak, ahpô ayitaw eyikoni.

kîspin owiyasiwew tâpwihtam peyak ahpô ayitaw anihi tipahikewina, ayisiyiniwak kâ-kaskihtâcik takahtinahkik tipahamâtowin (paspewiyiniwak, owikamikowâwa opîkiskwestamâkewâwa, ahpô nakatamâkaniwâwa) ka-sâkaskinahtâwak kwecihkeyimowin masinahikan. kahastew kakisipayik tipahikan takwecihkeyimohk môsihtâwin tipahikewin, ekwa kotak kispayan takwecihkeyimohk kitimahtâsowin tipahamâtowin.

anima kwecihkeyimowin masinahikan namôya ceskwa wiyastew, mâka ka-wihcasin tasâkaskinahtâhk. opîkiskwestamâkewak ayitaw ohci ekwa ana kwecihkeyimowin opimipayihcikew (atoskahowewak kâwîkinwâpahtahkik anihi masinahikana) kahkiyaw nistawinamwak eyikohk wîsakihtamowin okiskinwahamâkanak kâ-môsihtâcik ekota Île-à-la-Crosse kiskinwahamâtowikamik. kîspin peyak ahpô ayitaw anihi tipahikewina tâpwihtam owiyasiwew, ka-wiyascikâtewa eta paspewiyiniwak manâcihikik owîsakihtamowiniwâwa ekwa moy kahâyimahk ka-masinahamihk kwecihkeyimowin. kahastenwa wiyasiwewin ekwa mâmitoneyihcikan miywâyân sihtoskâkewina misikâme ekota kwecihkeyimowin itôtamowin.

## 7. NIYA KA-TIPAHAMÂN WIYASIEWEWIN ITAKIHTEWINA?

---

paspewiyiniwak mihcetinâtowin wîtahpisowak ekwa wahkômâkanak kâ-wîtahpisocik makîkway ka-tipahikewak ohci wiyasiwewin itakihtewina otasiwacikaniwâhk. anima kwecihkeyimowin itôtamowin eso osihcikâtek eta namôya ka-tipahwat opîkiskwestamâkew ka-wîcihtâsot.

aniki sihkitisahikewak opikiskwestamâkewâwa kîpe-atoskeyiwa ohci nîkipitamihk itakihtewina, ahpô makîkway itahtewina, ohci askiya ikospî anima sihkitisahikewin kâ-mâcihtâhk, ekota tâpwihtamowinihk takahtinamwak peyak “nânitaw ohci itakihtewin”, itweyimakan apisi sôniyahkewin kaskihowin ekota sihkitisahikewin ohci aniki paspewiyiniwak. ekosi ôma mihcet sihkitisahikewina esi itôcikâteki Canada

kîspin anihi tipahikewina tâpwihtamowin, aniki sihkitisahikewak opikiskwestamâkewâwa kakwecimewak owiyasiwewa ka-tâpwihtamiyit anihi wiyasiwewin itakihtewa okwecihkeyimowiniwâwa:

- \$8.5 million, plus tax, Canada ka-tipahahkik pîtos ohci anima Canada tipahikewin sôniyâw; ekwa
- \$8.5 million mîna kâ-takwastâhk tipahikan, kahkiyaw kîkwaya, ka-tipahahkik Saskatchewan ohci ekota Saskatchewan tipahikewin sôniyâw.
